### 1. Opening Remarks

The meeting commenced at 10am, chaired by the Principal Administrator Mr Ahmed. The chair welcomed all attendees, emphasizing the importance of stakeholder input in the county's development projects.

### 2. Overview of Financial Year Activities

The different department heads in Engineer Salim for Engineering and Development Control, Gabriel for the Environment and Ali for Accounts provided an overview of the upcoming financial year activities, highlighting the need for stakeholder engagement to ensure alignment with community priorities. The total allocation for the Urban Development Grant was stated to be 20 million, earmarked for specific development initiatives and Funding from the County Government for Development to be around 50 Million.

### 3. Discussion on Key Development Projects

#### a) Construction of Ring Road Phase II

Objective: To decongest Lamu Old Town by providing an alternative transport route.

Discussion: Stakeholders raised concerns about possible displacement during construction and suggested early communication and resettlement plans.

#### b) Construction of Vertical Drainage at Mkomani

Objective: To reduce stormwater stagnation and improve drainage.

Discussion: Emphasis was placed on using eco-friendly materials and ensuring minimal disruption to daily activities during implementation.

#### c) Construction of Waste Holding Sites

Objective: To manage waste efficiently and enhance cleanliness.

Discussion: Participants suggested conducting sensitization campaigns to educate the public on waste management.

#### d) CCTV Installation for Mkomani (Around Jetties)

Objective: To enhance security in the area, especially for the jetties, which are critical infrastructure.

Discussion: The security team emphasized the need for regular maintenance of the CCTV systems.

e) Opening up of Jua Kali Roads at Hindi

Objective: To improve accessibility and boost local economic activities.

Discussion: Local representatives requested that local labor be prioritized for the project.

f) Kenya Urban Support Program (KUSP) Phase II

Objective: To continue urban development initiatives under KUSP.

Discussion: The need for transparency and proper allocation of resources was emphasized.
